Special Trade Alert: 3-28-18

Dear Subscribers

The Big Tech Giants Facebook (FB) and Alphabet (GOOLG) have finally collapsed as I predicted a year ago.

Unfortunately we were so early on these trades that their collapses have only brought them to minor losses (FB is down 1% while GOOGL is down 2% for us).

It now looks like both companies' shares are bottoming.

So while I'd prefer we would have seen major winners here, unfortunately that's simply not in the cards.

With that in mind, the best thing to do is to close out these positions while they're only *marginally* down, rather than let them turn into large losses again.

Action to Take: Cover your Facebook (FB) Shorts for a 1% loss

Action to Take: Cover your Alphabet (GOOGL) Shorts for a 2% loss.
